When we started the 2020-2021 school year our team could only imagine the challenges, difficulties, and complications presented by working virtually with students during a global pandemic.

As schools, families and communities across the country adjusted to life during the COVID-19 pandemic, City Year and our district partners facilitated new ways to support students, teachers and classrooms while also continuing their own training and professional development online.

Our service never stopped, it just looked different.

- AmeriCorps members supported teachers in virtual classrooms, answered students' questions in chat boxes, and provided online tutoring sessions.
- Corps members worked to keep their teams connected and uplifted through frequent video calls and tips on how to provide self-care.
- AmeriCorps members made phone calls home to families, connected with their students, and checked in on how they and their parents were doing.
- Teams assisted teachers during online classes and provided support to help students and parents find assignments and materials so they can complete their schoolwork.

Relationships between AmeriCorps members and students are at the heart of City Year's work in schools. Students learn and develop much better when they feel safe, supported, valued and heard. City Year Columbus: Service in the Midst of COVID-19

SUPPORTING SCHOOLS AND STUDENTS

The COVID-19 pandemic caused the abrupt closure of schools and a shift to distance learning in March 2020. In response, City Year Columbus guickly adapted its operations to continue serving partner schools and students within the Columbus City School District.

Navigating the Transition

City Year Columbus staff and AmeriCorps members were proactive in working with school partners to offer support with assessing family needs, keeping families and students updated on plans for distance learning, and by providing information on how to access resources.

SUPPORT FOR DISTANCE LEARNING

AmeriCorps members supported partner teachers in the virtual space by providing small group academic, social, and emotional support, tracking student engagement (attendance and participation), answering student questions, providing technical support, integrating interactive activities into lessons, providing homework help, and facilitating other enrichment activities.

As the Columbus City School district moved into a hybrid learning model, City Year continued to collaborate with administrators and teachers to continue providing integrated services for students.

City Year Columbus' approach to personalized learning and development, along with its commitment to equity and the holistic well-being of AmeriCorps members, staff, students, and families, helped the organization successfully meet the needs of schools and district partners.

SUPPORTING AMERICORPS MEMBERS

To address AmeriCorps members' emotional well-being during the pandemic, City Year offered a myriad of services including community meetings, reflection activities, self-care offerings, professional development and mental health support.

With the support and generosity from board members, funders, and volunteers, City Year Columbus developed a site pantry deigned to support AmeriCorps members with essential supplies, hygiene items, and food as they continued to work during the pandemic.



Students stay in school, are more engaged and perform better academically when they feel connected to at least one adult at school. That is our role and our goal, to ensure that students have the relationships and resources to help them thrive in and out of school.




Every year, City Year Columbus recruits a diverse group of AmeriCorps members, ages 18-25, to spend a year in full-time service in Columbus City Schools, where they serve as student success coaches – near peer tutors, mentors and role models who provide holistic, personalized support to students as the cultivate foundational social, emotional and academic skills that are essential for success in school and in life.

During the 2020-2021 school year, 57 AmeriCorps members joined City Year Columbus with goals to support student success, advance educational equity, and build their personal and professional development.




Ethnicity



During their year of service, City Year Columbus AmeriCorps members are encouraged to form a Life After City Year (LACY) plan, an integral part of the AmeriCorps experience. By providing mentorship, networking opportunities, and professional development workshops, City Year is dedicated to supporting the growth of young people. During their service year, AmeriCorps members can hone multiple skills that provide them with opportunities which can translate into any career path they choose.

Sometimes, their LACY plans turn into "STAY-CY" plans, meaning they return to City Year, either as a second year Corps member, Team Leader, Service Leader, or a staff member.



Each year of service comes with many unprecedented challenges that Corps Members and students work together to overcome. This year, those challenges were unlike anything we could have imagined or prepared for as we faced a global pandemic and transition to virtual schooling. Our day-to-day lives changed drastically as we all had to adjust to staying home, wearing masks, and working remotely.

Each Corps Member who chose to serve this year took on the additional challenge of working in schools through a pandemic. What would our new roles be? How would classes work? How would we be able to build relationships with students, school staff, and each other? Will we be going back to school at some point? What will that transition be like? When will that transition take place?

Our first challenge was building relationships. Would building relationships with each other, school staff, City Year staff, and students be possible through a computer screen? Though we handled our preparation and training with intentionality, many of us did not have a clear idea if this would be possible or if it would be the same. As the year progressed, I watched my team become closer both personally and professionally. I have seen them lean on each other for support, brainstorm as grade-level partners, and create friendships through virtual spaces.




Our Funding Model
